Objectives

- To comply with legislation and local regulations relating to the company's environmental aspects.
- To ensure environmental impact is considered during the design and development stages of new products, adopting best practices to reduce waste at the source where possible.
- To reduce environmental impact from the company's operational and manufacturing activities by improving efficiency of processes identified through internal quality process audits.
- To prevent air, water and land pollution as far as reasonably practicable.
- To recycle or re-use materials whenever possible, including but not limited to; Packaging, Plastics, Electrical & Electronic Equipment, Metals, Batteries & Printed Circuit Boards, etc.
- To ensure recyclable and non-recyclable waste enters the correct waste streams for processing in compliance with their own legislation and regulations.
- To avoid or reduce the use of hazardous substances where possible.
- To minimise consumption of resources, reducing paper use and heating oil consumption.
- To promote the use of stainable resources when viable.
- To avoid or reduce the use of single-use plastics in our activities whenever possible.
- To encourage the company's suppliers and sub-contractors to minimise their use of single-use plastics when supplying goods and to adopt good environmental practices.
- To reduce reliance on non-renewable energy sources by utilising solar energy and battery storage.
- To replace old lighting with low energy lighting and adopt use of proximity switched lighting in areas that are unoccupied, in low use or not in use.
